## ***Our Town. Our Choices. Town Hall #2*** **Making Strategic Choices**

The second and final strategic planning Town Hall meeting is scheduled for Saturday, August 13, from 8:00 a.m. to 4:00 p.m. at the Community Center. This event is co-sponsored by the Town of Fountain Hills and the Fountain Hills Civic Association. Previous citizen input meetings and interviews set the stage by defining the core values and vision of the Town. Building upon the strategic direction set in the initial Town Hall held in April, the August Town Hall will involve weighing options and making choices based on financial realities. The citizen-driven planning process has been successful in engaging community residents in the task of charting the Town's future with over 270 residents participating in Town Hall #1. "We hope to have an even larger turnout and broader cross-section of the Town's residents at the August meeting," said Roger Riggert, President of the Fountain Hills Civic Association and member of the Technical Advisory Committee (TAC).

Prior to the Town Hall, registrants will receive a packet of information to help prepare for the day's activities. The packet will contain citizen input from Town Hall #1, as well as information about the Town's current financial position and future projections. "The issues are complex and citizens will need to make trade-offs in terms of financial, social and environmental impacts. This is a real opportunity for Town residents to exchange ideas and set priorities," added Curt Dunham, member of the TAC and Town Hall Subcommittee Chair.
